Lawyer Lipman collects big bucks in Seminole lawsuit win

Although last year was an exciting one for Boca Raton attorney Ken Lipman - he was local counsel for George Bush and Dick Cheney in the federal Florida election case in Miami this year has proven particularly rewarding for him. In January, he won the biggest civil case in South Florida, representing Prudential Insurance in a \$15 billion case against Jack Scarola. announced he's considering a run
for the nation's top office, putting
him in the pack with front-runners John Kerry, Joe
Lieberman and John Edwards

Larry Casey, who ran Republican U.S. Rep. Clay Shaw's successful re-election campaign, will be heading up Shaw's West Palm Beach office.

Speaking of GOP elections, there's talk that the Broward County party's former chairman, Ed Pozzuoli, might be drafted to run for chairman of the state party. So far, none of the potential contenders to replace Al Cardenas are from South Florida.

Broward County is looking to make the supervisor of elections an appointed office due to the flascos surrounding elections chief Miriam Oliphant.
